**CUMULATIVE ACTION AGAINST C-PLANET (IT SOLUTIONS) LIMITED, AND
AGAINST ANY OTHER ENTITY, POLITICAL PARTY OR INDIVIDUAL WHO WAS
INVOLVED WITH, OR HAS CONTRIBUTED TOWARDS, THE VIOLATION OF
THE PROTECTION OF PERSONAL DATA, INCLUDING ANY ENTITIES WHO
MAY BE AS YET UNKNOWN**

I recently discovered that my personal data were included in a database that was administered by, or in the possession of, **C-Planet (IT Solutions) Limited**, a company registered in Malta with the registration number C-41536 and with registered office at Telemetry House, 52 Conservatory Street, Floriana.

This database was for some time accessible to everyone through the internet, without restriction, and internet users were freely able to search and find my personal data, including sensitive personal data. This is data that I never wished to be made public, nor did I ever grant any consent to any person to render public.

The information included an indicator on what an unidentified third party considered to be my political opinion or political affiliation, or my lack thereof, which is an entirely private matter considered to be sensitive personal data by applicable data protection laws, and the publication of which – regardless of whether the data is correct or not – exposes me to damages due to the fact that the processing of such personal data is prohibited by law and may cause serious and real prejudice to my day-to-day life. I cannot exclude that I have already suffered consequences as a result of this data processing despite my being unaware of it to date.

The information also included telephone numbers for which, as personal data, I never provided consent for processing or publication in this way. I fear that this data was collected and/or processed in an abusive and illegal manner, and is still being used in a manner that is abusive, illegal and which threatens my right to privacy and other fundamental democratic rights, as well as other laws, international and European conventions to which Malta is a signatory, as well as those specific rights that arise from the General Data Protection Regulation (EU) 2016/679 (the 'GDPR').

By means of this document I therefore declare that I wish to joiner my complaint together with that of other individuals affected in the same way by means of this data privacy violation, through a cumulative action before the Courts of Malta, which action will be administered by Repubblika, a civil society organisation registered with the Commissioner for Voluntary
